TEST METHODOLOGY

The specimen mounting was performed according to ASTM E795-16: "Standard Practices for Mounting Test Specimens During Sound Absorption Tests." 



The sound absorption average (SAA) is defined in ASTM C423-17 Section 3.1.1 as the arithmetic average of the sound absorption coefficients of a material for the twelve one-third octave bands from 200 Hz through 2500 Hz, inclusive, rounded to the nearest integer multiple of 0.01.

The noise reduction coefficient (NRC) is defined from previous versions of ASTM C423 as the arithmetic average of the sound absorption coefficients at 250 Hz, 500 Hz, 1000 Hz, and 2000 Hz, rounded to the nearest integer multiple of 0.05.


